#### **REQUEST FOR PROPOSALS**

- I. You are invited to submit *a proposal by e-mail to the address stated in paragraph V*, for the below procurement activity in accordance with the enclosed Instructions and Information to tenderers.
- II. Your Proposal must be received by 23:59 o'clock on **November 26, 2024**, and shall remain open in the event that the aforementioned final date for submission of this procurement activity is extended. All submitted documents must conform to the requirements outlined in the tender dossier.
- III. You are required to complete and return all documents listed and requested at "**Documents to be submitted**" in accordance with the invitation to tender and instructions.

#### IV. Procurement Structure

This procurement process is organized into multiple LOTs. Each LOT has distinct terms of reference and related documentation, which must be followed in your application. Ensure that your proposal clearly specifies the LOT for which you are applying.

Auditing firms may submit proposals for multiple LOTs.

KCSF will make all efforts to avoid a situation where the same auditor is contracted for all LOTs. This is why no firm will be awarded more than three LOTs, and these must not be interrelated within one program.

Additionally, auditors who are currently or have previously been involved in auditing the last phases of the respective LOT cannot be selected again for the same LOT.

#### LOT 01: External Audit for the EJA 2 Kosovo Program (ISA 805)

LOT 1 involves an External Audit for the EJA Kosovo Program Phase 2, co-funded by the Swiss Agency for Development and Cooperation (SDC) and Sweden. The total program budget is EUR 4,278,496.19, with EUR 2,527,662.75 to be allocated to grants supporting civil society organizations in Kosovo. The audit will cover the program's financial information for fiscal years 2024, 2025, 2026, 2027, and 2028, in accordance with International Standards on Auditing (ISA 805).

These audits are spread throughout different programs of KCSF and the organization as a whole.
