Media Conference on Opening the Project "Challenges of Treatment of Constructions without Permits" and the signing of a Memorandum of Cooperation between the Project (NGO CDO) and the Planning and Urban Planning Directorate in the Municipality of South Mitrovica. 2. Prepare the research on the current state of legalization process in the Municipality of South Mitrovica. 3. Organize 2 debates / roundtables with the topic "Challenges of dealing with illegal constructions" with the participation of relevant actors from local and central institutions, citizens, organizations dealing with this issue, media. 4. Organize 4 public hearings between the Directorate of Planning and Urbanism and citizens of South Mitrovica / interested applicants for the legalization of illegal objects. 5. Prepare the report with recommendations from all project activities and referral to decision-makers. 6. Prepare and distribute leaflets to raise awareness about the legalization of unauthorized objects. 7. Editing of spots for citizen awareness regarding the legalization of illegal objects, through electronic media.
Results:	<ol style="list-style-type: none"> 1. Citizens will receive knowledge about the new draft law and knowledge of the entire application process for legalization, 2. Citizens are empowered and mobilized to participate in public hearings and to talk with decision makers on inters, 3. The number of people interested in applying for legalization in the new stages of the new draft law will increase, 4. The recommendations and outcomes of the 7-month project will be valuable material for the Planning and Urban Planning Directorate in the Municipality of South Mitrovica and the relevant central level institutions (MMPH and Kosovo Assembly).
